### Maureen Walliser Honored by the National Conference for Community and Justice

“I am honored to receive this award,” said Maureen Walliser, president of HCE. “NCCJ is an organization that does pioneering work which, step by step, is building a society where diversity is valued and respected,” she said. “Besides arming our program participants with the knowledge and expertise they need to navigate today’s job market, we teach our students to understand and appreciate that every person deserves respect for who they are regardless of ethnicity or religion,” she said. Maureen Walliser has been a driving force in creating and implementing HCE’s vocational programs for special needs students and adults for over 20 years. HCE was the first vocational services organization in the United States to introduce and successfully operate a social enterprise. Additionally, HCE continues to be the favored agency to supply Fortune 1000 companies with special needs employees.

Other recipients of the 2004 Humanitarian Award include Marilyn Bennett, executive director of Horizon Health Center; Sallie Porter, executive director of Hudson Cradle; and Elnora Watson, executive director of the Urban League of Hudson County.
